
Dear SafePlace community,

It is an honor to serve as Executive Director of SafePlace, an agency with over 40 years of serving Thurston County survivors and their children. 2021 has been difficult for so many of us trying to manage the stressors of everyday life while navigating the new obstacles of living during a worldwide pandemic. Yet through all that, we persevered. We showed compassion to those that needed it most. We adapted to ever-changing plans. We found positives in seemingly negative situations.

SafePlace has a similar story during this timeframe, continuing to provide needed services in this community while adjusting to the changes in how we all communicate and interact. For example, staff went from never having used Zoom before to now advocating at court cases that are conducted fully remotely. SafePlace has been able to adjust to these changes without compromising the quality of services, and mostly because of strong community partnerships and wonderful support from local stakeholders.

Thank you all for your integral role in keeping SafePlace a robust agency with wrap around services for survivors and their children that would otherwise not be able to live a life without violence. - **4,009** Crisis Calls to the 24/7 Helpline
- **5,609** shelter bed nights provided
- **60.9%** of shelter residents were under 18 years old
- **124** households received supportive housing services
- **438** legal advocacy referrals from outside agencies
- **440** walk-in clients met at the SafePlace Community Services Center
- **1,208** hours of volunteer services provided
- **47,151** SafePlace website visits
- **838** students attended Healthy Relationships Workshops at Thurston County Schools

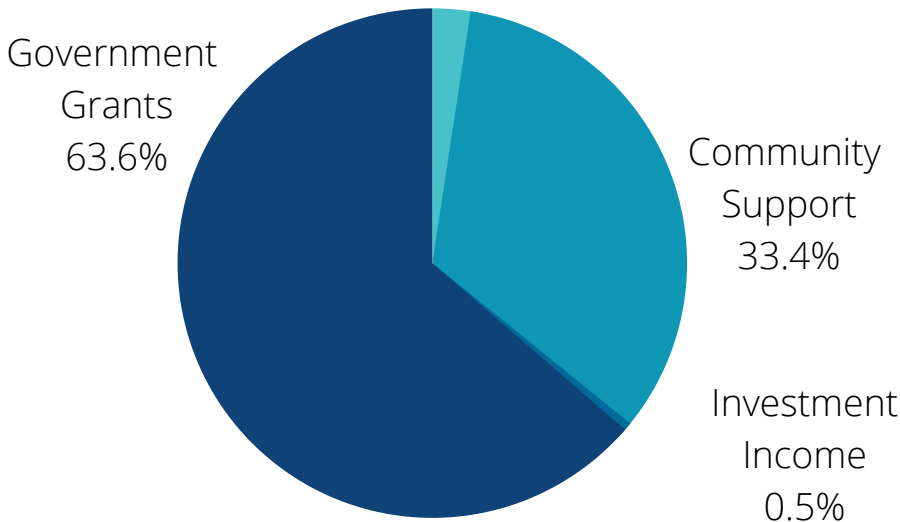

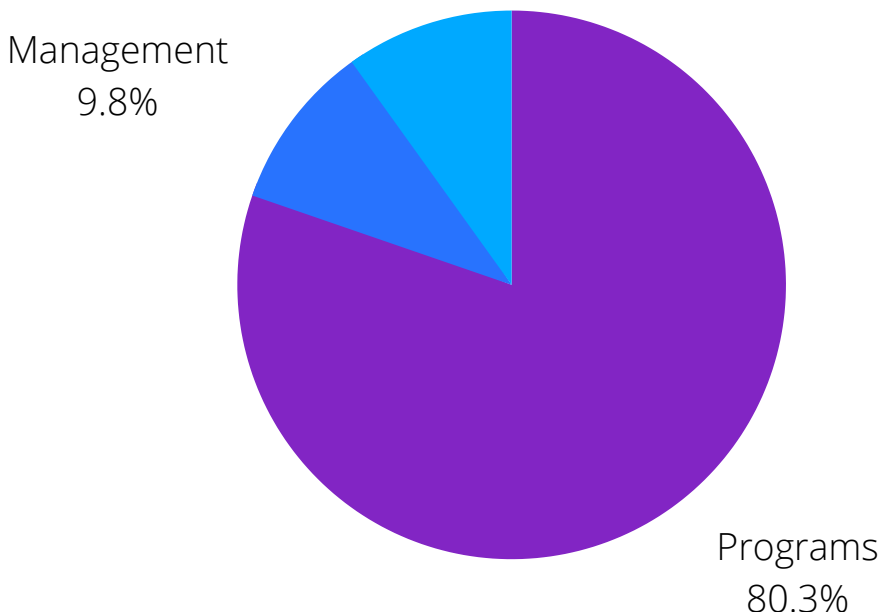
